

NOTICE OF EXTENSION IN BIDS SUBMISSION DATE

The bid submission date for the tender namely "E-GOVERNANCE CONSULTANCY SERVICES FOR BUSINESS PROCESS RE-ENGINEERING STUDY AND IMPLEMENTATION SUPPORT FOR THE PROJECT OF AUTOMATION OF STAMPS & REGISTRATION IN ALL DISTRICTS OF SINDH" published in leading newspapers vide No.INF-KRY.2231/15 dated: 06-06-2015, was fixed as Wednesday, 24th June 2015. However, on account of declaration of public holiday by the Government of Sindh, the schedule of bid submission was postponed and bids submission was extended under Rule 22 of SPP Rules 2010 till 11:00 AM on Tuesday 30th June 2015 vide notice hoisted on the website of Board of Revenue, Sindh, i.e. www.borsindh.gov.pk. However, on account of delay in publication of the notice in newspapers and SPPRA website, the last date for submission and opening of bids is hereby further extended. The fresh date of submission of bids for the said tender shall be Monday, the 6th July 2015 till 11:00 AM. The technical proposals of submitted bids will be opened by the Consultant Selection Committee on the same day at 11:30 AM. In case however the bids submission and opening schedule is not conducted on the prescribed date on account of any emergent situation posing a natural calamity or declaration of public holiday by the Government of Sindh, the bids submission and opening timelines would be extended to next working date.
